General Release Form

I, PARENT/GUARDIAN OF: _____ ("MY CHILD") HEREBY GIVE MY CONSENT TO ALLOW MY CHILD TO PARTICIPATE IN ALL ASPECTS OF THE OTTEWELL COMMUNITY LEAGUE PLAYSCHOOL PROGRAM. I SPECIFICALLY GIVE MY CONSENT TO ALLOW MY CHILD:

- A. TO PARTICIPATE IN ANY AND ALL CLASSROOM ACTIVITIES ARRANGED AND/OR SUPERVISED BY THE INSTRUCTOR, MEMBERS OF THE PLAYSCHOOL EXECUTIVE, OR A DUTY PARENT;
- B. TO PARTICIPATE IN ANY AND ALL GYMNASIUM, PLAYGROUND OR OTHER ACTIVITIES, WITHIN OR ON THE PREMISES OF BRAEMAR SCHOOL, ARRANGED AND/OR SUPERVISED BY THE INSTRUCTOR OR DUTY PARENT;
- C. TO PARTICIPATE IN ANY NATURE WALKS OR OTHER WALKING FIELD TRIPS ARRANGED AND/OR SUPERVISED BY THE INSTRUCTOR OR A DUTY PARENT;
- D. TO BE TAKEN TO USE THE BATHROOM FACILITIES BY THE INSTRUCTOR OR A DUTY PARENT;
- E. TO PARTAKE IN THE DAILY SNACK AND JUICE TO BE PROVIDED BY THE DUTY PARENTS, INCLUDING MYSELF, FOR EACH DAY OF CLASS; AND
- F. TO RECEIVE EMERGENCY MEDICAL AID FROM THE INSTRUCTOR. A DUTY PARENT, OTHER TEACHER OF BRAEMAR SCHOOL OR ANY EMERGENCY MEDICAL PROFESSIONALS WHICH MAY BE CALLED UPON BY THE INSTRUCTOR OR A DUTY PARENT TO PROVIDE EMERGENCY MEDICAL AID SERVICES. SUCH EMERGENCY MEDICAL AID MAY INCLUDE THE TRANSPORTATION OF MY CHILD TO A HOSPITAL, BY AMBULANCE OR PRIVATE VEHICLE, WHERE SUCH TRANSPORTATION IS, IN THE OPINION OF THE INSTRUCTOR OR A DUTY PARENT, NECESSARY.

WHEN PREPARING THE SNACK OR JUICE IN MY CAPACITY AS A DUTY PARENT, I EXPRESSLY AGREE THAT I SHALL UNDERTAKE THE PREPARATION OF THE SNACK OR JUICE IN ACCORDANCE WITH CURRENTLY ACCEPTED HYGIENIC STANDARDS AND PRACTICES. I UNDERSTAND THAT THE OTTEWELL COMMUNITY LEAGUE PLAYSCHOOL ACCEPTS NO RESPONSIBILITY FOR THE CONTENT OR QUALITY OF THESE FOOD ITEMS.

I ACKNOWLEDGE THAT IT IS MY RESPONSIBILITY AND OBLIGATION TO ADVISE THE INSTRUCTOR AND THE EXECUTIVE OF THE OTTEWELL COMMUNITY LEAGUE PLAYSCHOOL OF ANY ALLERGIES OR OTHER CONDITIONS THAT MY CHILD MAY HAVE WHICH MIGHT AFFECT MY CHILD'S ABILITY TO PARTICIPATE IN THE ACTIVITIES ENUMERATED ABOVE.
